Michael Vick Sentenced to Prison for Illegal Dogfighting

Michael Vick was sentenced to 23 months in prison and three years probation for his role in the "Bad Newz Kennels" dogfighting operation and his participation in the brutal killing of several dogs that did not "perform well". During his sentencing the suspended football star apologized to the court and his family. However, Judge Henry Hudson told him, "You need to apologize to the millions of young people who looked up to you".

In August, Michael Vick entered a plea agreement stating that he took part in an illegal, interstate dogfighting enterprise. In documents filed, Vick said he knew dogs that did not perform well were killed. He said the fights involved gambling although he did not personally place bets. Judge Hudson called Vick's actions "cruel and inhumane" and said that Vick was a full partner in "Bad Newz Kennels" and was

therefore equally culpable in all crimes committed. Two of Vick's codefendants were also sentenced and received between 18 and 24 months.

Morningstar Farms to Use Fewer Eggs

In 2007, Compassion Over Killing (COK), Vegan Outreach (VO) and United Poultry Concerns teamed up with caring people everywhere in urging Morningstar Farms, a Kellogg subsidiary, to offer more vegan items by removing eggs from its products.

According to company spokeswoman Kathleen Eckler, in 2008 "Kellogg is reducing the amount of eggs we use in our Morningstar products by a minimum of one million eggs. We're committed to announcing even more new vegan products for our customers." By reducing Kellogg's egg usage by more than one million eggs per year, nearly 4,000 fewer laying hens will suffer in factory farms each year.

Senate Passes Farm Bill with Pet Safety & Protection Act Attached

The Senate passed its version of the Farm Bill with the Pet Safety & Protection Act (PSPA) attached as an amendment. (The House also passed the PSPA in July as part of the Farm Bill.)

The next step for the bill to move forward rests with the House and Senate Agriculture Committee Members who will go to conference to iron out any differences in the language of their respective bills. All U.S. Medical Schools Now No Longer Kill Dogs

By February 2008, all American medical schools will have abandoned a time-honored method of teaching cardiology: operating on dogs to examine their beating hearts, and disposing of them after the lesson. Case Western Reserve School of Medicine was the last to use the method, but the dean said it would no longer do so after next month.

Among the 126 American medical schools, 11 still sacrifice animals other than dogs for teaching.

Denny's Ends Ringling Bros. Partnership

After months of letters, e-mails, calls, and demonstrations, Denny's has ended its partnership with notorious animal abuser Ringling Bros. and Barnum & Bailey Circus. Your letters, e-mails, and calls make all the difference in letting companies know that animal abuse is not tolerated by caring consumers.

This is a huge victory for elephants, tigers, and other animals who are dragged around the country in cramped boxcars and forced to perform silly and often painful tricks under the threat of beatings and punishment. With this announcement, Denny's joins other compassionate companies like MasterCard, Visa, Liz Claiborne, and Sears, Roebuck and Co., which all ended their sponsorship of Ringling after learning of the abuse inherent in circuses that use animals.

Urge Federal Legislators to Support Several Critical Measures to Protect Pets in Final Farm Bill

Several measures to protect pets are being considered for inclusion in the final Farm Bill: Measures that would stop the use in research of random source dogs and cats obtained through "Class B dealers," stop the importation of puppies from foreign puppy mills for commercial sale, strengthen the federal law against dogfighting, increase the maximum penalties for Animal Welfare Act (AWA) violations, and require the U.S. Department of Agriculture to resume providing annual reports on its AWA enforcement efforts.

Travel agency AAA is teaming up with infamous animal abuser Ringling Bros. and Barnum & Bailey Circus by offering discounted tickets to Ringling events.

Please take a minute to tell AAA that compassionate consumers are outraged when any company promotes Ringling. Also let the travel agency know that Ringling has earned universal condemnation by animal protection organizations, elephant experts, and animal advocates.

After learning of the abuse inherent in animal circuses, major corporations like Denny's, General Mills, Burger King, Liz Claiborne, MasterCard, Visa, and Sears, Roebuck and Co. ended their sponsorships of circuses like Ringling and UniverSoul, another circus that forces animals to perform confusing and often painful tricks. Now it's time for AAA to do the same.

Urge PetsMART to Stop Selling Birds

PETsMART has temporarily suspended the sale of birds in approximately 775 stores in 44 states across the U.S., after birds in 23 PETsMART stores tested positive for avian chlamydiosis (also called psittacosis) — a disease that is transmittable to humans. The disease is suspected to have originated with a major bird vendor/distributor in Florida — where birds are mass-produced and shipped all over the country to stock pet shops. This includes major pet shop chains PETsMART, Pet Land, and Superpetz.

Of further concern in this case is that it has been revealed that the Florida distributor (with approval from PETsMART) uses antibiotics as a prophylactic treatment — dosing birds with antibiotics whether the birds have the bacteria or not. But only birds confirmed to be sick should be treated for disease.

Now is the time to help turn PETsMART's temporary suspension of sales into a permanent change. Urge PETsMART to stop selling birds in its stores, and to instead work exclusively with bird rescue groups and/or to refer customers interested in birds directly to the rescue groups.
