New Program Launches, "Animal Planet Investigates"

A new Animal Planet series, "Animal Planet Investigates," began airing on January 25th by taking a closer look at dogfighting. Future specials will examine a variety of animal protection issues including puppy mills and other issues that audiences are passionate about within the animal world.

Karley's Murderer Found Guilty in Court

Los Angeles Assistant Fire Chief, Glynn Johnson, was found guilty of felony animal cruelty with special circumstances (maximum penalty of up to 3 years) and use of a deadly weapon to commit a felony (maximum penalty of up to 1 year), after brutally beating to death a six-month old puppy named Karley.

OCPA closely followed this case and attended several demonstrations and trial sessions at the Riverside County Superior Courthouse. Sentencing is scheduled for Monday, March 8th. For further updates about this case, visit http://www.justice4karley.com.

West Hollywood Bans Sale of Dogs and Cats Acquired from Mills

The West Hollywood California City Council recently voted to ban the sale of dogs and cats acquired from puppy/kitten mills. The ordinance passed unanimously, and now pet stores in the city will only be able to sell dogs and cats from shelters.

Florida County Votes to Prohibit Bullhooks at Zoo-Backed Elephant Center

In a major victory for elephants, the St. Lucie County, Florida Board of Commissioners made it very clear that the use of cruel bullhooks on elephants is not welcome in their county by imposing strict conditions on the National Elephant Center (NEC). The NEC cannot use bullhooks on elephants, must limit the number of elephants held at the center, and were encouraged to form an advisory committee to monitor elephant welfare.

Michigan State University Ends Dog Labs at Vet School

The College of Veterinary Medicine at Michigan State University will no longer require terminal surgery labs to teach veterinary students. Terminal surgery labs use healthy animals, particularly dogs, to practice surgical skills, after which the animals are killed. Ending terminal surgery labs and replacing them with more humane teaching methods allows MSU to join the majority of the 28 other veterinary medical schools in the U.S. that no longer include terminal surgeries in their curriculum. MSU will instead use sophisticated models, animal cadavers, and an increased number of spay and neuter operations which benefit animals at shelters.

Canadian School Board Approves Student Choice Policy

The Burnaby, BC School Board recently agreed to create a formal policy giving students the right to say "no" to dissection.

Russian University Ends Animal Labs

Perm State Pharmaceutical Academy in Russia recently declared an end to all animal laboratories at its school; it will instead implement humane alternatives to animal labs – joining nine other institutes of higher education in Russia.

Action Items - Your Letters/Calls Needed

Urge California Dept. of Fish & Game to Ban Bear Hunting

The California Department of Fish and Game (CDFG) has proposed dramatically expanding bear hunting across the state. CDFG has recommended increasing the hunt quota from 1,700 to 2,500 bears, or eliminating a cap altogether, and expanding hunting into other areas of the state. The agency also plans to allow the use of global positioning system (GPS) collars and treeing switches on dogs while bear hunting. (A treeing switch alerts hunters when hounds have chased a bear up a tree.)

Every year, hunters legally kill more than 2,000 bears across California. An estimated 40,000 to 50,000 black bears are legally hunted each year in the US and Canada, while an unknown number are also illegally poached. Shockingly, it is legal for trophy hunters in California to chase bears with packs of hounds. More information is available here: http://www.bigwildlife.org/front animal page.php?page=7.

Talking points to include: Trophy hunting puts additional pressures on bears, who face a host of increasing threats from poaching, habitat fragmentation and destruction, human encroachment into wildlife areas, aggressive government lethal control programs, and climate change. Black bears often scavenge for food, playing an important role in recycling carrion. Bears also help transport berry seeds. State wildlife officials have failed to assess the impacts of poaching. Illegal killing of bears has increased globally, fueled by a booming international market, for bear parts, especially bear gallbladders used in traditional Asian medicine and bear paws, considered a delicacy in soup. The state has also failed to assess the impacts of annual increases in bears killed by hunters.

Sign Petition to Interior Secretary to Stop Wolf Slaughter

The war on wolves is getting uglier by the day. It's tragic enough that a record 402 wolves were killed last year in Idaho and Montana after their removal from the endangered species list. This is an astronomical level that amounts to one-third of the entire wolf population in those two states. To make matters worse, hunters have been employing barbaric tactics in the savage slaughter of these beautiful animals.

Ask U.S. Representative to Support HR 503/S 727, Prevention of Equine Cruelty Act

Each year, tens of thousands of American horses—riding horses, carriage horses, race horses, wild horses, and children's ponies—are inhumanely transported and slaughtered, their meat shipped to places like France, Italy, and Japan for human consumption.

Purchased by slaughterhouse middlemen at auction, horses are shipped long distances in cramped trailers without food, water, or rest. The majority of these horses are young, healthy animals who could go on to lead productive lives with loving owners.

You can help end the slaughter of horses by asking your senators and representative to support The Prevention of Equine Cruelty Act (H.R. 503/S. 727). It will ban the barbaric slaughter of American horses for human consumption, including the export of live horses across our borders for slaughter.

Sign Petition to Support New Bill, SB 1277, to Create California Animal Abuser Registry

California Senator Dean Florez (http://dist16.casen.govoffice.com/) – in conjunction with the Animal League Defense Fund – has introduced a bill, SB 1277, to create a California state animal abuser registry. Any person over the age of 18 convicted of felony animal abuse would be required to register with local law enforcement, much like current registries for convicted arsonists and sex offenders. The registry would be paid for by a pet food fee/tax of approximately 3 cents/bag (\$10 annually), and any excess funds would be given to community spay/neuter programs.

Research has shown that animal abusers are five times more likely to commit violent acts against people and four times more likely to commit property damage. Each year, thousands of animals are subjected to violence, torture, mutilation, sexual abuse, animal fighting, hoarding, etc. Creating the proposed registry would help prevent animal abusers from obtaining pets and keep our communities and safer.

Demand Freedom for Captive Whales at SeaWorld

The fatal attack of a trainer recently at SeaWorld, Orlando by a killer whale should come as no surprise. This was the third time this whale, Tilikum, lashed out at a human resulting in a death. It was the second time in two months that a trainer was killed by an orca at a marine park.

The response from a SeaWorld spokesperson was that they need to give these whales "more hugs and affection." The trainer was being affectionate and rubbing Tilikum at the time of the attack...

When will humans learn that keeping wild animals in captivity causes dire consequences for both people and animals alike? Urge SeaWorld to get out of the captive whale business. Foie Gras Demonstrations – Various Dates and Locations in January and February

OCPA and the Animal Protection Rescue League's (APRL) foie gras campaign is still going strong. We held peaceful demonstrations on the following dates at these restaurants that continue to serve foie gras:

Southern California animal rights activists, combined with OCPA and Animal Protection and Rescue League (APRL), began a six-week campaign in January against the serving of foie gras as a "delicacy" in Orange County restaurants. The "86 Foie Gras Campaign" was directed toward five high-end Orange County restaurants: Hush, Pascal, French 75, The Winery and Marche Moderne.

Foie gras is produced by force-feeding lard and other matter through a rough steel pipe shoved down ducks' throats three times a day. The intent is to overfeed the ducks until their livers swell to ten times their normal size. The swollen and diseased livers are then served as a delicacy called "foie gras." The ducks suffer intense pain and severe injuries that often result in ruptured organs. This practice is so injurious and debilitating to the ducks and geese that they are unable to walk or stand.

The 86 Foie Gras Campaign is an opportunity for California consumers to educate restauranteurs about this cruel and inhumane practice and request the sale of it stop now. The campaign asks local activists to either send educational letters or call the restaurants to voice their concerns about the issue, or to attend the peaceful protests to help raise awareness of this issue.

OCPA and APRL, along with many So. Cal. activists, have successfully convinced a number of local restaurants to take foie gras off of their menus, including Five Feet, The Sky Room, DaVinci's, Mr. A's, Hammamori, and Laurel's. Foie gras is not just unhealthy for the ducks; humans who eat the diseased liver are consuming a near toxic food that is 85% fat.

With the goal of opening an ongoing dialog between individuals who are in favor or against the use of animals in biomedical research, UCLA Bruins for Animals and Pro-Test for Science participated in a panel discussion on this complex topic entitled *Perspectives on the Science and Ethics of Animal-Based Research*. This event occurred on Tuesday, February 16th between 6:00 and 8:00 p.m. at UCLA, Covel Commons.

This event was structured to maximize the opportunity to engage in a civil, intellectually honest discussion on issues about which people hold passionate, differing opinions. Three panelists on each side will briefly present their personal views on the topic, followed by moderator-driven discussion and questions from the audience. The event was moderated by David Lazarus of the Los Angeles Times.

The panel participants were:

Janet D. Stemwedel, Ph.D., Associate Professor of Philosophy, San Jose State University. Professor Stemwedel will discuss her views about the ethical issues around animal use in scientific research.

Ray Greek, M.D., President of Americans for Medical Advancement. Dr. Greek will discuss his views about the use of animals to predict human response.

Colin Blakemore, FMedSci FRS, Professor of Neuroscience, Oxford University. Professor Blakemore will discuss his views on the role of animal research in medicine and public health.

Niall Shanks, Ph.D., Professor of History and Philosophy of Science, Wichita State University. Professor Shanks will discuss the /prediction problem/ in biomedical research.

Dario L. Ringach, Ph.D., Professor of Neurobiology and Psychology, University of California, Los Angeles. Professor Ringach will present is views on the role of basic science in driving medical advancement and knowledge.

Robert Jones, Ph.D., Assistant Professor, Department of Philosophy, California State University, Chico. Professor Jones will discuss the philosophical and ethical implications of using nonhuman animals as subjects in medical and scientific research.
