## Good News for the Animals!

### ***Connecticut Considers Ban on Traveling Elephant Exhibits***

A bill was recently introduced in Connecticut that would prohibit the use of elephants for entertainment purposes by traveling shows, theatrical exhibitions and circuses.

### ***Cockfighting Ban Passes in New Mexico***

House Bill 878 to ban cockfighting in New Mexico passed with a 50-15 vote without debate or the presence of cockfighting proponents.

### ***Tel-Aviv Bans Animal Circus Acts***

The Municipality of Tel-Aviv banned animal circus acts and will avoid any future contracts with circuses that use animals of any sort in their shows. This great achievement was a result of an Anonymous for Animal Rights campaign that incorporated public campaign and political lobby. Hopefully, other cities in Israel and abroad will follow Tel-Aviv's humane and enlightened decision.

## **Action Items – Your Letters/Calls Needed**

### ***Stop Rabbit Slaughter in Mission Viejo***

It was brought to OCPA's attention recently that residents at Casta del Sol, a senior gated community in Mission Viejo, have recently received authorization to shoot rabbits using pellet guns. OCPA board members sent a letter to the Mission Viejo City Council voicing our objection to the senseless murder of "nuisance" animals. The letter follows at the end of this e-alert.

Please write the Mayor and City Council as soon as possible, reminding them that there are other, non-lethal and humane methods of dealing with wild animal overpopulation in communities such as Casta del Sol: Mayor Patricia Kelly, Members of the City Council, 200 Civic Center, Mission Viejo, CA 92691.

### ***Support SB 662, Humane Slaughter of Poultry Amendment***

The California Animal Association is sponsoring an important bill. SB 662, the Humane Slaughter of Poultry Amendment, which seeks to amend California's method of slaughter law to include spent hens and small game birds. OCPA has joined over a dozen other California humane organizations to create a cohesive force on behalf of the animals.

Please contact the Senate Committee on Agriculture and your Senators as soon as possible and ask them to support this important bill. Remind them that all animals used for human consumption should be provided humane oversight and regulation. ### ***Help Save Elephants at L.A. Zoo***

Many elephants suffer and die premature deaths due to arthritis, chronic foot infections and other conditions caused by an inappropriate environment.

IDA is working with the L.A. City Council and others, informing them of the fact that elephants in captivity sicken and die prematurely due to lack of space. Even with the L.A. Zoo's plan to spend \$12 million to renovate the elephant exhibit, they could never provide the vast amount of space necessary for keeping elephants healthy and alive.

### ***Support Bill to Ban Dog Ear Cropping in CA***

An Assembly Member introduced AB 418, a bill that would ban the cropping of a dog's ears, unless for therapeutic purposes, in the state of California. If passed into law, it would be the first ear cropping ban in

the U.S. The bill was introduced on behalf of the Association of Veterinarians for Animal Rights that represents more than 3,000 veterinary members nationwide.

Despite past opposition from dog breed clubs, the bill is expected to receive support from the veterinary profession, the animal welfare community and the public.

The San Diego Animal Advocates has planned the following activities:

- **Saturday, April 2:** Leafleting and public outreach at the San Diego Convention Center  
Time: 11:00 am to 2:00 pm  
Meeting location: The plaza at the Gaslamp Quarter Trolley Station (station #33), 5th Avenue and Harbor Drive (next to the Tin Fish restaurant; look for the sign that says "SDAA")  
Details: They'll provide leaflets for volunteers to distribute to the public and to convention attendees. If anyone would like to remain there after 2:00 pm and continue to leaflet, please do so! Please scroll down to read their note on transportation.
- **Sunday, April 3:** Demonstration and street theater at the San Diego Convention Center  
Meet at: 11:00 am  
March and demonstration: 11:30 am to 2:00 pm  
Meeting location: The plaza at the Gaslamp Quarter Trolley Station (station #33), 5th Avenue and Harbor Drive (next to the Tin Fish restaurant; look for the sign that says "SDAA." Please scroll down to read their note on transportation.

Details: The theme will be "The Mad Scientists," and the SDAA will provide about 30 white (and "bloodied") laboratory coats and monster masks for participants who wish to wear them, as well as plenty of signs, banners, and leaflets for everyone. If you prefer to do your own "monster vivisector" makeup, please do; SDAA encourages everyone to be creative and express themselves here. If you happen to have them, please bring any LARGE stuffed animals that could represent lab animals-- monkey, dog, cat, rabbit, mice, etc.--and they will put them in 'cages' as part of the demonstration. In addition, we have planned a piece of street theater that will require about 10 reliable volunteers. Nothing scary; it will just involve a short ride in a car, then walking across the street to join the protest...in an extremely entertaining fashion. - **Monday, April 4:** Press conference in front of the Convention Center with Mike Budkie of Stop Animal Exploitation Now! ([www.all-creatures.org/saen](http://www.all-creatures.org/saen)). Location, time, and details are still being planned, but keep in mind this won't be a demonstration so they don't need a large turnout of volunteers for this--although having some supporters onsite to hold a sign or banner would be appreciated.

***Re: Killing Rabbits with Pellet Guns***

Dear Mayor Kelly,

We were horrified to learn of the Council's action to approve a variance for pellet gun use in the firearms ordinance in order to kill rabbits at the Costa Del Sol senior community. The fact that this action passed unanimously gives us great pause. If local government fails to promote conscientious and humane treatment of wildlife, then the community is also unlikely to consider other, non-lethal options to similar challenges.

In a recent email from Council Member MacLean to one of our members, he stated that a variety of alternatives has been attempted in the past to control the rabbit population at Costa Del Sol. However, a quick search of available information reveals that methods such as that approved by the Council are cruel and short-sighted. If they are killed, rabbits from the surrounding area will soon replace any removed.

In fact, many of the rabbits living in colonies at golf courses, on college campuses, and in urban parks around the country are actually domestic rabbits, released by their former guardians when they no longer wanted them. Like wild rabbits, domestic rabbits will breed prolifically, and can cause damage to plants. Unlike American wild rabbits and hares, domestic rabbits (who are descended from European rabbits), will burrow, creating elaborate warrens underground.

If there is a population of feral rabbits who are most likely domestic (i.e., they may be colors other than brown, and they are living at least part time underground), these rabbits should be captured with humane traps and brought to a local humane society or rescue organization. House Rabbit Society ([www.rabbit.org](http://www.rabbit.org)), a national rabbit rescue and education organization, provides information on humane capture, and has chapters across the country that may be able to help solve these kinds of problems. In some areas, volunteers have been able to catch, spay or neuter, and re-release these rabbits into the

areas in which they were living. While this may not solve the problem, it at least eliminates the population explosion that results from rabbits being released into the wild.

Other methods include using rabbit-proof fencing around gardens by burying fencing one foot beneath the ground, three feet high, and wrapping trees with wire mesh as well. Other solutions include purchasing non-lethal repellent and spraying it around any garden areas to discourage rabbits from feeding there.

We urge you to contact Protect R Wildlife at [ProtectRWildlife@aol.com](mailto:ProtectRWildlife@aol.com) as well as the Humane Society of the United States at [www.hsus.org](http://www.hsus.org) for alternate, more humane solutions to the rabbit overpopulation situation at Costa Del Sol.

It takes the same amount of effort to buy and use pellet guns and remove dead rabbit carcasses as it does to find and implement a humane solution. The difference is in the long term outcome, both in terms of the rabbit population and the example set for your community.
