SB 1578, Dog Anti-Chaining Bill, Passes Senate and Assembly

SB 1578, the dog anti-chaining bill, passed both the Senate and the Assembly Business and Professions Committee. The bill next faces the Assembly Appropriations Committee some time in August. We'll send committee contact details and additional information in the next e-alert. Once passed, this bill will ban the practice of chaining or tethering a dog to a stationary object as the primary means of confinement. Not only is chaining dogs inhumane and unsafe for the animals, but SB 1578 will give animal control an additional tool to protect our canine companions from long-term neglect and reduce incidences of dog bites and attacks in our community.

Philadelphia Considers Foie Gras Ban

Following Chicago's lead in becoming the first American city to outlaw the sale of foie gras (diseased duck and geese liver), Philadelphia may also ban the cruel product. According to City Councilman, Jack Kelly, who introduced the legislation, "Force feeding birds to make an expensive appetizer is cruel and unnecessary, and it should not be condoned in our society."

Welch's Ceases Animal Experimentation

It's hard to imagine why a company that makes grape juice would test on animals, but it was. In one experiment, dogs' chests were cut open to induce massive blood clotting, and a tube was then attached to their stomachs in order to pump them full of grape juice. Afterward, the experimenter collected blood samples by "fresh puncture" of the dogs' hearts. In another experiment, hundreds of rats were poisoned with toxic chemicals, fed grape juice, and cut up to observe the effect that it had on their bodies. Those are just a few of the tests that were conducted on innocent dogs, monkeys, rabbits, and rats.

After PETA warned the company that it was prepared to launch an international boycott campaign to educate the public about its cruel and deadly animal experiments, Welch's recently agreed to stop funding all animal tests. Following Welch's groundbreaking decision to adopt a formal policy against animal testing, juice companies Ocean Spray and Tahitian Noni International adopted similar policies after hearing from thousands of caring people around the world and examining the evidence against animal experimentation. PETA continues its efforts to convince POM Wonderful to follow suit and stop animal testing.

Ralph Lauren Goes Fur-Free

After corporate representatives were shown video footage from a fur farm in China, Ralph Lauren announced a precedent-setting decision, based purely on ethics, to no longer use fur in any of its apparel or home collections. Way to go, Ralph!

Urge Representative to Support H.R. 503 to Stop Commercial Sale and Slaughter of Horses

If passed, H.R. 503 – the American Horse Slaughter Prevention Act – will end the slaughter of horses for human consumption and the domestic and international transport of live horses or horseflesh for the same purpose.

Ask Senators to Pass H.R. 3858 to Protect Animals in Natural Disasters

After passing both the House and Senate, the Pet Evacuation Bill (HR 3858/S 2548) also recently passed the California Senate Committee on Government Operations (A.B. 450). This important legislation now faces consideration in the Senate Committee on Appropriations. The PETS Act requires state and local emergency management agencies to take into account the needs of individuals with pets and service animals in the event of a major disaster.

Contact Assembly Committee to Support SB 1806, Companion Animals in Vehicles

The California State Senate approved SB 1806, making it a crime to leave or confine a companion animal in an unattended vehicle under conditions that endanger the health or well-being of the animal. Leaving animals unattended is a dangerous and potentially fatal mistake – and the dangers increase during warmer weather when temperatures inside a parked car can reach above 100 degrees F.

Urge Assembly Committee to Support SB 1349, Anti-Cockfighting Bill

The Anti-Cockfighting Bill, SB 1349, recently passed the California state senate and now faces a vote in the Assembly Committee on Public Safety.

This bill will increase penalties for animal fighting by permitting felony charges to be brought against a person who is arrested a second or subsequent time for illegal cockfighting. Nevada, Oregon and Arizona have all passed felony laws against cockfighting; because of this, California has unfortunately become a haven for thousands of illegal cockfighters statewide.
