#### NBA Goes Leather-Free

Beginning with its 2006/2007 season, the National Basketball Association (NBA) is opting to permanently bench leather balls in favor of better-performing, cruelty-free synthetic basketballs, like those already in use by the National Collegiate Athletic Association and the Women's National Basketball Association.

#### Notorious Class B Dealer Sentenced in Federal Court

The largest USDA-licensed Class B animal dealer and pet theft ring operator was sentenced in federal court to three years probation and six months home detention following his guilty plea in August 2006 to felony charges of conspiracy to launder money in an operation involving the sale of dogs and cats to research laboratories. Baird's wife, Patsy, was sentenced to two years probation for misprision of felony mail fraud. The Baird's criminal fines were \$10,000.

The case against Baird comprised the largest multi-agency investigation of animal abuse in U.S. history. According to Chris DeRose, Last Chance for Animal's president, this case has set a precedent for future prosecutions against violators of the Animal Welfare Act. Now that Baird has been successfully prosecuted and is a convicted felon, prosecuting future abusers will be much easier.

#### Bill Introduced to Ban Foie Gras in New Jersey

A bill was recently introduced that bans the production of foie gras in New Jersey, making it the seventh state to contemplate outlawing the force-feeding of ducks and geese in order to sell their enlarged, diseased livers. In 2004, California became the first state to pass legislation in banning foie gras. Other bills to ban foie gras are currently being considered in Hawaii, New York, Illinois, Massachusetts and Washington states.

## Urge House Subcommittee Members to Support the American Horse Slaughter Prevention Act (AHSPA) – Immediate Action Needed

The House Subcommittee on Commerce, Trade and Consumer Protection is preparing to review the AHSPA in a hearing scheduled for Tuesday, July 25<sup>th</sup>.

If the AHSPA passes, the slaughter of horses for human consumption and the domestic and international transport of live horses or horseflesh for the same purpose will be outlawed in the U.S. Every year, more than 90,000 horses are either killed in one of three foreign-owned slaughterhouses in Texas and Illinois or shipped to Canada or Mexico for slaughter. Polls indicate that the vast majority of Americans want the slaughter of horses for human consumption banned.

#### Ask Senate Committee to Pass AB 2862 to Protect Animals in Pet Stores

AB 2862 is a bill that will strengthen state law governing the treatment of animals at pet stores by setting specific standards of care, filling gaps in the law, and providing tools for improved enforcement of pet store laws. This bill has passed the state assembly and is waiting approval in the Senate Business, Professions and Economic Development Committee.

Please contact your senator and show your support for this important bill before August 1<sup>st</sup>. If you have witnessed pet shop abuse or substandard care of animals in pet shops, feel free to include your personal experiences and observations in your letters.
