## Good News for the Animals!

### ***SB 1806 (Protects Companion Animals in Hot Cars) Passes California Senate and Assembly***

SB 1806 – a bill that will make it unlawful to leave a companion animal unattended in a motor vehicle – recently passed both the California Senate and Assembly. The bill now moves to Governor Schwarzenegger for his signature on this important bill. Refer to the *Action Items* section of this e-alert to contact the governor and ask him to sign this bill.

### ***AB 2862 (Helps Animals in Pet Stores) Passes California Senate***

AB 2862, a bill that addresses gaps and weaknesses in state law governing the care of animals in pet stores, also recently passed the California Senate. The bill now moves back to the state assembly for a concurrence vote. Refer to the *Action Items* section of this e-alert to contact your assemblymember and ask them to support this bill.

## ***AB 2485 (Saves California Sea Otters) Passes State Senate***

AB 2485, the bill to save California sea otters, recently passed the State Senate. This bill now also moves to Governor Schwarzenegger for his signature. Refer to the *Action Items* section of this e-alert to contact the governor and ask him to sign this bill into law.

## **Action Items – Your Letters/Calls Needed**

### ***Urge U.S. Representative to Support HR 503 – the American Horse Slaughter Prevention Act (AHSPA)***

A vote is expected on the American Horse Slaughter Prevention Act (AHSPA/HR 503) when Congress returns from its recess the week of September 6<sup>th</sup>.

If the AHSPA passes, the slaughter of horses for human consumption and the domestic and international transport of live horses or horseflesh for the same purpose will be outlawed in the U.S. Every year, more than 90,000 horses are either killed in one of three foreign-owned slaughterhouses in Texas and Illinois or shipped to Canada or Mexico for slaughter. Polls indicate that the vast majority of Americans want the slaughter of horses for human consumption banned.

### ***Urge Governor Schwarzenegger to Sign SB 1806 (Protect Companion Animals in Hot Cars) and AB 2485 (Save California Sea Otters)***

SB 1806 has passed both the Senate and Assembly and now awaits Governor Schwarzenegger’s approval and signature. Once signed, this bill will make it unlawful for anyone to leave a companion animal unattended in a motor vehicle under conditions that could endanger the health of the animal.

AB 2485, the bill to save California sea otters, also passed the State Senate and awaits governor approval and signature. Sea otters were once nearly hunted to extinction and still face a perilous road to recovery. Only about 2,700 sea otters now live in California, but their journey back from the brink has stalled in recent years. Threats from oil spills and other pollution, habitat degradation, and disease continue to plague these wonderful creatures. But the legislation on Governor Schwarzenegger’s desk will help provide the added protection our sea otters desperately need to survive.

### ***Contact Assemblymember for Concurrence Vote on AB 2862 (Helps Animals in Pet Stores)***

AB 2862 is a bill that will strengthen state law governing the treatment of animals at pet stores by setting specific standards of care, filling gaps in the law, and providing tools for improved enforcement of pet store laws. This bill has passed and has now passed the Senate Business, Professions and Economic Development Committee and moves back to the Assembly for a concurrence vote.

### ***Protect First Amendment Rights – Urge Representative/Senators to Oppose the Animal Enterprise Terrorism Act, HR 4239 and S 1926***

Believe it or not, a bill is now pending in the House and Senate (HR 4239 and S 1926) that would devastate the animal rights community. This bill – also known as the Animal Enterprise Terrorism Act – would effectively make it a crime to engage in non-violent actions and make it illegal to cause a loss of profits to any business considered an "animal enterprise." This includes factory farms, vivisection labs, circuses, fur farms and other businesses which routinely inflict unimaginable suffering and pain on animals who cannot speak to defend themselves. Even if the loss in profits to the company results from peaceful protests, effective boycotts or media campaigns, under the language of this law, it could be interpreted as a violation that could impose a hefty prison sentence of several years.

This bill is clearly unconstitutional and violates First Amendment freedom of speech. We cannot allow our government to silence our voices for the animals.

Join Last Chance for Animals, HSUS, OCPA and other organizations who vehemently object to this legislature; write, call and/or e-mail your senators and representatives NOW to urge them to oppose these unconstitutional bills! Honorable [Representative name and address]

I am concerned about pending legislation that challenges America's foundation of free speech. As your constituent, I respectfully ask you to oppose the Animal Enterprise Terrorism Act (H.R. 4239), a bill drafted to shield animal-use corporations from legal protest. If H.R. 4239 is enacted, non-violent objection and civil disobedience, boycotts, and even influential media campaigns would become terrorist activities if linked to "loss of profits" for agribusiness, research laboratories, fur farms, circuses, and other "animal enterprises."

Please do not support H.R. 4239, introduced by Rep. Thomas Petri [R-WI], or any companion bill in the Senate that outlaws dissent if it leads to "economic damage." Under the Animal Enterprise Terrorism Act, citizens who exercise their First Amendment rights to free speech, free assembly and free expression are labeled terrorists and face significant time behind bars. Moreover, the subjective phrase "loss of profits" apparently includes overhead to restore lost or damaged property or records, expenses for duplicating suspended or invalidated experiments, etc. Will H.R. 4239 focus on property crimes alone or criminalize lawful whistleblowers and undercover cruelty investigators as well?

I fail to understand the purpose of this bill. Disciplinary measures already exist for vandalism, trespassing, or other unlawful behavior. The overwhelming majority of animal protection advocates never engage in illegal activity. But even if they did, they should be prosecuted under present laws.

I do not view demonstrations against animal experimentation facilities or distribution of literature outside an animal circus as terrorism any more than I view anti-war or women's health protests as terrorism. Will Congress propose similar Terrorism Acts to cover all areas of opposition?

Exposing animal cruelty may upset business and slow revenue, but it's hardly a form of terrorism. This unconstitutional bill establishes a model for repressive legislation to silence all social justice movements. I sincerely hope you are among those legislators who disagree with this shameful attempt to equate activists with terrorists. H.R. 4239 is an insult to the true victims of terrorism.

No animal activist in the U.S. has ever caused grave human injury or death. I am baffled as to why my government representatives believe I need the Animal Enterprise Terrorism Act to feel safe. In fact, I would feel far more secure if the Department of Homeland Security focused on legitimate domestic security threats. Thank you for your valuable time and consideration in this serious matter.
